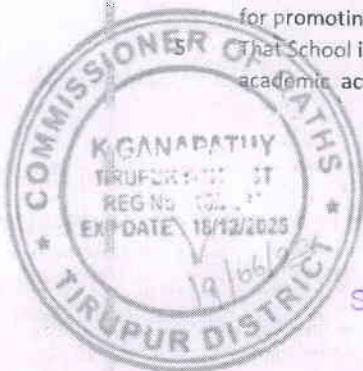

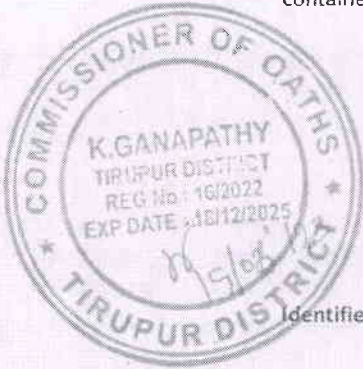

- 6 That the School will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7 That the Principal and Correspondent/ Manager of the school have individually gone through the provisions contained in the affiliation & examination by_laws and the circulars issued by the Board from time to time. The School Undertakes to abide by the provisions contained in the affiliation & examination by_laws , directions issued from time to time and the law of the Land.
- 8 That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour etc., with Labour Laws etc., with respect to the school and staff of the school.
- 9 That the school will ensure that the Building Safety , Fire Safety , Water Safety , Health and Hygiene certificates are being issued or renewed by the concerned Municipal or State Authorities from time to time as per the prescribed term.
